PLEASE READ AND SIGN THE FOLLOWING PRIVATE CART AGREEMENT

I (We) have read the following Rules and Regulation as they pertain to the use and storage of private golf carts at the Bellows Falls Country Club, Inc.

1. Owners of private golf carts at the Bellows Falls Country Club must be members of the Club.
2. There will be no subleasing of cart spaces.
3. The maximum number of owners of a private golf cart is two (2) members.
4. If a private cart is inoperable, the owner(s) must rent a cart from the Club and not use a private cart owned by another member.
5. All private cart and storage fees are to be paid by May 1, 2012, or private cart privileges will be revoked.
6. Owner(s) agree to keep their cart and cart parking space policed at all times.
7. Owner(s) agree to abide by any other rule or regulation that may be adopted by the Board of Trustees.
8. Private golf carts that are left on Country Club grounds are left at the sole risk of the cart owner(s).

LIABILITY

I (We) further agree that I (we) will not hold the Bellows Falls Country Club, Inc., its Officers, Staff, or Trustees liable for any damage to my (our) golf cart, nor will we hold the Club or its Officers, Staff, or Trustees liable for any injury that may result from the use of a private cart.

PERMISSION TO RENT

I (We) hereby (give) (do not give) permission to the Bellows Falls Country Club, Inc., to rent (my) (our) golf cart to other members or guests when needed by the Club. (Circle Choice)

(The need for additional carts occurs occasionally for tournaments when all of the Clubs leased carts are in use. The Club will keep you free of expense, including gassing up your cart.)

CART MAINTENANCE

I (We) understand that private cart maintenance charges should not go through the Club, but should be billed directly to the owner(s).

This Agreement is effective for the 2012 season, and it must be returned with your Membership and Private Golf Cart and Storage Fees. Agreements that are not returned may result in the loss of private golf cart privileges. A violation of this Agreement may result in the loss of private cart privileges.
